



## COVID-19 PLANS & GUIDELINES

Our team is working diligently to provide a safe and sanitary church experience so that we can continue to connect, grow, and serve together.

SUNDAY

Sunday morning service times are: 9:00 AM and 10:30 AM.

- In order to maintain the service capacity of 50 people, we ask every guest to RSVP for their service. If you are not able to sign up online, please call ahead (630) 791-5007. The RSVP link will be released on our website and social media.
- To maintain health standards and social distancing recommendations, we are:
  - refraining from physical contact (hugs, high fives, hand shakes, etc.)
  - rearranging the sanctuary to provide a 10 ft. distance between families
  - highly recommending the use of masks, though it is not required
  - providing sanitizing stations throughout the building
  - moving toward contact-less offering through offering box stations
  - disinfecting all surfaces in between services
  - recommending all vulnerable persons or those who are sick to remain home
- Due to the typical volume of people at the coffee station, there will be no coffee or donuts provided.
- FaithBridge Kids and nursery areas will remain closed. We encourage families to sit together in service. We will provide activities for children during the service.
- Due to the new service times, there will be no Sunday School and only one prayer time at 8:00 AM.
- After the service, guests will not be allowed to linger in the lobby in order to make room to sanitize the area. We encourage guests to continue conversations outside.

ONLINE

During this time we will continue providing online opportunities to connect.

- We will continue to livestream our 10:30 AM service. The entire service will be livestreamed to Facebook, YouTube, and our website.
- Wednesday night services will continue online.
- We will not be continuing the Monday or Friday zoom meet-ups.

## **COVID-19 POSITIVE PROCEDURE**

**If someone tests positive that was in a public service or meeting at FaithBridge Church or one of our ministries within the time frame set by CDC guidelines (2 days prior to positive test, or anytime after until quarantine) we will...**

- Immediately commence with a detailed disinfecting of the areas where the person was and the whole church.
- Send an email letter out notifying the church that someone was in our public service that tested positive and that if you were considered a close contact by CDC guidelines you will be contacted further.
- Send a text through our church text service to direct you to check your email about the expected communication.
- We will require that the person that tested positive refrain from coming to church until at least the quarantine period is over.
- Those who received notification as one who had close contact with the individual will be asked to self quarantine according to the CDC and DuPage County Health Department guidelines.
- If the positive tested person was a ministry volunteer, leader, board member, or staff the church will help in contacting those known to have had close contact as outlined by CDC guidelines.
- If the person that tested positive was not in any of those positions then we will direct that person to make contact personally with those who were in close contact.
- In keeping with stated Health Department guidelines, we will also be contacting the Health Department to notify them about the exposure and bring them up to speed on what measures we have taken.

### **In looking to the next public service opportunity...**

- If we have met the CDC guidelines for notification, disinfection, cleaning, and safety then we will proceed with the next scheduled public service.
- We will use the CDC guidelines for communities of faith as our baseline. Recognizing that if things change, we may need to as well, and we will continue to work with our local health department.
